Steve Piekarec '74 — Director (2017-2019)

Steve graduated from the College of Arts & Sciences '74 (started in Engineering) and is a CCW Life Member. He is currently the longest tenured Board member and first joined the Club in 1993. He has served as an officer of CCW for 12 years, including President from 2009 to 2011. He was also First Vice-President, Past President, VP Programming (7 years in 2 separate stints), VP Network and Outreach and has served as a Director. He has been an active CCW member and received the Bondareff Award in 2013.

Kwame Campos Rodriguez MBA '15 — Director (2017-2019)

In December 1965, both boards approved a merger agreement, and a referendum vote was mailed to the alumni. The two presidents at the time, Edwin Miller '35 and Lori Eisenberg '50, completed their terms. For the following year (1966-67), Phillip Fleming '52 was elected the first president of the newly consolidated group.

Honoring CCW Past Presidents

Past President Kim Jones Gilliam is one of Cornell's busiest local alumnae! Now in her fourth year operating her own familyrun business, Frolick Dogs, with her husband Kevin, Kim took a few moments to reflect with us on her time at Cornell and with CCW.

Kim attended Cornell for her undergraduate studies (CALS '98) and for her MBA ('02). While an undergrad, she was active both in campus life – working

as a TA for a marketing professor and riding at the university's Equestrian Center – as well as around Ithaca, volunteering with the vet school's Cornell Companions program, taking her cat to visit residents in a local home for individuals with Alzheimers. While completing her MBA, Kim reports she was the youngest person in her class and "so had lots of enthusiasm and energy to become very engaged." And become engaged she did! She served on the Student Council, was elected to the Alumni Class Council, served as a TA once again, sang in the Sound Investments a cappella group and played on the Frozen Assets women's hockey team.

One of her favorite memories from her time at the Johnson School was a "Pie in the Face" contest, an idea Kim proposed for the Community Impact club's efforts to fundraise for a local food bank. In the contest, students would vote on which of their favorite faculty, staff or classmates would get a pie in the face in the school's atrium. Kim's successful inaugural effort raised lots of money for the cause, offered a raucous good time for the school, and it even became an annual tradition!

Shortly after completing her MBA, and after a summer working in Ithaca on the Johnson School alumni relations team, Kim moved to DC in the fall of 2002. "Within weeks" of her arrival, then-President of CCW Chuck Schilke sought her out and invited her to dinner. By the end of dinner, Kim had agreed to fill an open board slot for the next year – not realizing at the time it put her on the road to her own later CCW presidency (2007-2009). Through the years, Kim served in a number of other capacities for CCW, including VP Technology, Secretary and First Vice-President. She has served on the Cornell Alumni Council and is currently the Reunion Chair for her Johnson School class (which just had its 15-year reunion and won the attendance record!).

Kim notes that the best reasons local alums should join CCW are the opportunities to connect with others and to attend top-notch events in the area. Looking back on her time as CCW President, she is most proud of one such event – an evening in March 2009 with New York City Public Schools Chancellor Joel Klein, Columbia '67 and his DC counterpart, Michelle Rhee, Cornell '92, organized in collaboration with other DC Ivy League alumni clubs. Rhee and Klein talked with moderator David Johns, education policy advisor to Senator Edward Kennedy, about the two most closely watched public school system overhauls in the country. Such events highlight the best things about CCW: the energy and enthusiasm required to make them happen, and the chance to come together as a community to learn and engage together.

Member Spotlight

Elina Hum '79, Tax Attorney and Founder of Hum Law Firm

Tell us something about yourself? I graduated from Cornell in 1979 and majored in Government, but took many classes in the English and History departments. Almost immediately after I arrived at Cornell, I joined a recently-formed group on campus called the Asian American Coalition. At that time, "Asian American" was newly coined. While many Americans of Asian descent identified themselves by their countries of heritage, there was a burgeoning movement to identify ourselves as Asian Americans based on the belief that in the United States there are unique shared experiences among Americans whose families originated from Asia irrespective of their countries of origin. Our little group convinced Cornell to begin offering classes in Asian American Studies. We persuaded the university to hire Victor Nee, then a graduate student, as the instructor of the first course offered at Cornell in Asian American Studies. Professor Nee is now a professor of Sociology at Cornell. Fast forward to recent times and a few years ago, at an event for law students to network with practicing attorneys, I met a young woman who casually

mentioned that she received her undergraduate degree from Cornell and was an Asian American Studies major. I was wonderstruck! I have to count working with others of the Asian American Coalition to spearhead the Asian American Studies program at Cornell among the accomplishments of which I am most proud.

What is your favorite memory from Cornell? I have many pleasant memories from my years at Cornell. One of my favorites is walking back to my room after the library closed for the night. The campus was deserted and I felt like I owned the whole beautiful place. My favorite class and professor would have to be the great Oliver Wolters and his seminar "Early Southeast Asian History." The late Professor Wolters was a giant in his field. The majority of my classmates in the 200-level seminar were graduate students, who took the class just so they could study with him. His egalitarian treatment of all his students propelled by his singular thirst for knowledge continues to be an inspiration. I can still see him getting all excited whenever anyone in his class raised his or her hand.

When did you move to DC and what brought you here? I first came to DC in 1979 to study law at Georgetown. In 1985, after I received my LLM in Taxation at NYU Law School, I returned to DC to clerk for the late Judge William M. Fay at the United States Tax Court. From there I went to work as a tax associate for the law firm of Dickstein Shapiro in DC and I subsequently opened my own tax law practice here in the mid-1990s.

Why did you join CCW? Do you volunteer with any other Cornell groups? When I was working as an associate at Dickstein Shapiro in the late 1980s, many of my friends from Georgetown and the Tax Court had left the area. DC has a large transient population; many people are here only a few years for work and then they move on. So it is very difficult to make new friends. CCW was the perfect way for me to have a social life. Besides serving on the CCW Board, first as Director-at-Large for three years and now as Treasurer, I had been active with my class during reunion planning. Throughout the past few decades, at all times, I was able to find CCW events and programs that were of interest to me even as I got older and my life style and interest changed accordingly. I guess one can say that throughout the many changes and stages of my life CCW was always a constant. When I first joined CCW I met many active and dedicated Cornellians such as Connie Geerhart '52 who recruited me for CAAAN. I interviewed high school students whose applications were pending, and I also sometimes met Cornell international students who came to DC to welcome them here. Spending time with young people always inspires me to do more and to learn more. They are energetic and fearless; "reverse mentoring" yields tangible benefits, not the least of which is finding out about the latest technology.

Best part about living in DC? Favorite place/restaurant/venue? I love that DC is a city where so many people from all over the world come to visit or work. While having lunch at a restaurant near DuPont Circle recently I overheard three languages spoken among the few tables of diners around me and the song playing softly in the background in the restaurant was in a fourth language! My favorite places in DC are the Smithsonian museums and galleries. I get in for free, I can stay as long as I like until closing, and I can see exquisite work by world-famous artists, or experience and learn about cutting-edge technology, or get transported back in human or natural history.

Remembering Bob Day '56

Robert Edward Day, Jr., '56, of Silver Spring, MD, and a long-time and active member of the Cornell Club of Washington, died peacefully on June 24, 2017. While at Cornell, he rowed for the school and crew became his lifelong passion. He was also a member of Quill and Dagger, Sigma Phi fraternity and cheered for Cornell athletics at a time when all cheerleaders were men!

Following Bob's graduation from Cornell, he was a Fulbright Scholar at Tubingen University in Germany, and became a career diplomat for the U.S. Department of State with embassy postings in East Germany, Poland, Yugoslavia and Iran. When Bob returned to the DC area in the 1980s, the late Ed Berkowitz '56, one of Bob's best friends in college and former CCW president and general counsel, persuaded Bob to join CCW. Bob and his wife, Diana Day '56, became active supporters of the CCW and their commitment to the Club and to Cornell was unwavering. In 2007, Bob received the Bondareff award to honor his outstanding commitment to CCW. He organized countless CCW programs and won several Best Program Awards, such as the State Department tour in 2003 and the Tour of Ezra Cornell's Achievements in 2014. Bob also helped Kathleen Miller '82 win Best Program Award for "Cornell on the Anacostia" in 2001. In addition, in 2015, Bob celebrated the life of Ed Berkowitz, his friend who had recruited

him to the CCW, by bringing Ithaca-made Silent Movies with live musical accompaniment to the Avalon Theater. None of Bob's friends could think of him without mentioning his love for rowing, and it was that love that linked Bob to DC beyond CCW. Gladys Stifel '58 recalls the first time she met Bob. He had come to a CCW Board meeting to request funds to purchase a rowing teaching barge. Paul Pearlstein and Carl Cole also remember that time well. Bob wanted to restart rowing on the Anacostia River for DC youth, who lived east of the river, so that they could get a shot at attending college by winning rowing scholarships. Together with friends like Paul and Carl, Bob started the Organization for Anacostia Rowing and Sculling ("OARS") in 1988. A May 12, 1992, Washington Post article under the headline "Rowing comes to the Anacostia" marveled at the first regatta on the Anacostia in 101 years thanks to OARS. The article described how, during the race, a coxswain for a local junior high school four-man crew who was less than five feet tall and barely weighing 80 pounds became a "towering commander." The 14 year-old seventh grader declared, "it's better being a leader." Thus was the influence of Bob and his team on DC's youth and of him on CCW.

Join Alumni and Cornell in Washington students for our 64th and semiannual trek into the Blue Ridge Mountains! Old Rag Mountain is one of the Washington area's most popular excursions. The first 1/3 of the strenuous, 9-mile hike (summit 3268 ft.; elevation gain 2300 ft.) is on an uphill trail through the trees, while the upper part is open and rocky. Bring lunch and water in a day-pack, and be sure to wear a hat and sturdy shoes. The total time needed for climbing, enjoying the view, eating, and descending is about 6 hours.
